The inclusion of people with lived experience in their own mental health recovery and in the design and delivery of mental health services is a central value of MHI. Mental health was one of the areas which pioneered the concept of including people with lived experience in all aspects of research, moving beyond participating as research subjects to the codesign, oversight and conduct of research. This is called public and person/patient involvement or PPI. MHI is partnering with the Mental Health Engagement and Recovery Division (MHER) of the Health Service Executive (HSE) in the development of Person and Public Involvement (PPI) in mental health and other research nationally. We wish to recruit a Project Officer to support us in this work.

# Eligibility criteria and qualifications

The successful candidate will:

- Raise awareness of the role of PPI what it is and what it can contribute to the research process in mental health research and other research involving people with lived experience;
- Co-produce and co-deliver training for people with lived experience / family members / supporters to become involved in PPI at all levels: from one-off consultation and engagements to becoming peer researchers;
- Support the development of PPI 'ambassadors'
- Identify and deliver training for service providers and researchers in what PPI is and how to engage effectively;
- Develop local networks of PPI contributors;
- Work with academic partners to create higher level training opportunities for peer researchers;
- Develop supportive governance structures and policies to ensure the work of this project is embedded and of high quality.
