### CONSTITUTION

of

## **MEMORANDUM OF ASSOCIATION**

Capitalised terms used in this Memorandum of Association shall have the meanings given to those terms in the Articles of Association.

### 1 NAME

1.1 The name of the company is "Mental Health Ireland" (the "Company").

### 2 COMPANY TYPE

2.1 The Company is a company limited by guarantee, to which Part 18 of the Act applies.

### 3 PRINCIPAL OBJECTS

- 3.1 The principal objects for which the Company is established are to benefit the community through the promotion of mental health by:
  - 3.1.1 promoting the general welfare of people with mental health difficulties;
  - 3.1.2 supporting people with mental health difficulties and/or their families and carers;
  - 3.1.3 promoting positive mental health and wellbeing by the provision of information and by advocating on behalf of people with mental health difficulties and/or their families and carers;
  - 3.1.4 the provision of education and training programmes that promote positive mental health and wellbeing and/or supports those with mental health difficulties; and
  - 3.1.5 promoting positive mental health and wellbeing to all individuals and supporting people who experience mental health difficulties on their journey of recover.

### 4 SUBSIDIARY AND ANCILLARY OBJECTS

4.1 The objects set out hereafter are exclusively subsidiary and ancillary to the principal objects set out above. These objects are to be pursued only for the attainment of those principal objects and any income generated therefrom is to be applied for the principal objects only. As subsidiary objects:

- 4.1.1 to be the national co-ordinating, servicing and representative body for locally and regionally based Mental Health Associations in their work in mental health matters;
- 4.1.2 to assist in the establishment and operations of Mental Health Associations and of associations/organisations whose principal objects conform to those of the Company;
- 4.1.3 to work with and care for the needs of people experiencing mental health difficulties who may be experiencing deprivation, social exclusion and/or unemployment, through lack of social support, medical support, affordable and/or adequate housing;
- 4.1.4 to promote, conduct, arrange ,sponsor and support:
  - (A) research into matters relating to mental health and the general welfare and social needs of persons experiencing mental health difficulties;
  - (B) educational programmes and activities for the purpose of creating public awareness and understanding of mental health and the prevention of the social exclusion of people who are experiencing mental health difficulties; and
  - (C) programmes aimed at creating a society that is caring of, just to, equitable to and inclusive of people who are experiencing mental health difficulties:
- 4.1.5 to provide support, expertise, information and advice to the Mental Health Associations in relation to management and organisational issues in addition to policy and practice in relation to their work for mental health.

## 5 POWERS

- 5.1 The Company shall in addition to the powers conferred on it by law have the following powers which are exclusively subsidiary and ancillary to the principal objects and which powers may only be exercised in promoting the principal objects. Any income generated by the exercise of these powers is to be applied to the promotion of the principal objects:
  - 5.1.1 to recruit, train and educate volunteers and/or paid employees and other personnel;
  - 5.1.2 to appoint, employ or engage any executive, officer, secretary, administrator, technical officer or other employees or agents, with or without remuneration or salary or wages or fees or pension, either full-time or part-time, who shall not be Directors, for the purpose of assisting the Company to achieve its objects;
  - 5.1.3 to provide educational, advisory and other publications, visual aids, legal, technical and other resource services, including a central information office and reference library;
  - 5.1.4 to provide education and training seminars, workshops and conferences, either directly or in conjunction with other bodies, on mental health matters;

- 5.1.5 to consult, co-operate and liaise with other organisations, associations, bodies and institutions in Ireland and elsewhere in the world having similar aims and objects as the Company;
- 5.1.6 to prepare and make submissions and representations pertaining to matters related to the principal objects of the Company to any government department, commission or committee and to statutory, public and private bodies;
- 5.1.7 to purchase or otherwise acquire, hold as an investment and deal in any shares, debentures, stocks, treasury bonds, scrip bills, notes and other securities issued by any company or association or any supreme, municipal, local or other authority wheresoever located;
- 5.1.8 to engage in any business or activity and to undertake, provide and carry out any service or contract of works and provide any facility and carry out any research which is deemed necessary or advantageous in promoting the principal objects of the Company or for the purpose of generating capital or income to facilitate the furthering of the principal objects of the Company;
- 5.1.9 to promote and further the principal objects of the Company by facilitating conferences, meetings, discussions, publications, conducting studies and surveys, and by such other means as may be deemed desirable or necessary;
- 5.1.10 to advertise and make known the Company and its objects, purposes and aims by such means as may be deemed expedient;
- 5.1.11 to solicit, receive and hold donations, subscriptions, gifts and bequests of all kinds and to raise money to further the principal objects of the Company by all lawful means including collections, flag days, subscriptions and other fundraising activities;
- 5.1.12 to act as trustees of any property real or personal for the principal objects of the Company, or for any other purpose that may seem conducive to the principal objects of the Company;
- 5.1.13 to operate within Ireland residential accommodation, sheltered, supportive and other forms of social housing and provide any form of social support or assistance as may be appropriate for people experiencing mental health difficulties;
- 5.1.14 to acquire by purchase, exchange, lease, fee farm grant or otherwise, whether for an estate in fee simple or for any less estate or interest, whether immediately or reversionary, and whether vested or contingent: any lands, tenements or hereditaments of any tenure, whether subject or not to any charges or encumbrances and to hold, farm, work or manage or to sell, let, alienate, mortgage, lease or charge land, houses, property, shops, flats, maisonettes, reversions, interests, annuities, life policies and any other property real or personal, movable or immovable, either absolutely or conditionally and either subject or not to any mortgage, charge, ground rent or other rents or encumbrances and to pay for any lands, tenements, hereditaments or assets acquired by the Company in cash or debentures or

- obligations of the Company, whether fully paid or otherwise, or in any other manner:
- 5.1.15 to invest and deal with the monies and property of the Company not immediately required in such manner as may from time to time be determined. Prior permission to be obtained from the Revenue Commissioners where it is intended to accumulate funds for a period in excess for two (2) years;
- 5.1.16 to borrow and raise money and to secure or discharge any debt or obligation of or binding on the Company in such manner as may be thought fit and, in particular (without limitation), by the creation of charges or mortgages (whether legal or equitable) or floating charges upon the undertaking and all or any of the property and rights of the Company both present and future, or by the creation and issue on such terms and conditions as may be thought expedient of debentures, debenture stock or other securities of any description;
- 5.1.17 to lend and advance money or give credit to any organisation pursuing the same principal objects as those of the Company and/or to guarantee and give guarantees or indemnities for the payment of money of the performance of contracts or obligations by them;
- 5.1.18 to apply for, promote and obtain any Act of the Oireachtas, order or license of any Minister of the government of Ireland or other authority for enabling the Company to carry its principal objects into effect or for any other purpose which may seem expedient, and to oppose any proceedings or applications which may seem calculated, directly or indirectly, to prejudice the Company's interests;
- 5.1.19 to enter into any arrangement with any governments or authorities (supreme, municipal, local or otherwise), or any corporations, companies or persons that may seem conducive to the attainment of the Company's principal objects, and to obtain from any such government, authority, corporation, company or person any charters, contracts, decrees, rights, privileges and concessions which the Company may think desirable, and to carry out, exercise and comply with any such charters, contracts, decrees, rights, privileges and concessions;
- 5.1.20 to grant pensions, gratuities, allowances or charitable aid to any person who may have served the Company as an employee, or to the wives, husbands, children or other dependents of such person provided that such pensions, gratuities, allowances or charitable aid shall be no more than that provided by a pension scheme covered by Part 30 of the Taxes Consolidation Act 1997 and provided that such pension scheme has been operated by the Company and the beneficiary of the pensions, gratuities, allowances or charitable aid, or their spouse or parent, has been a member of the pension scheme while employed by the Company; and to make payments towards insurance and to form and contribute to provident and benefit funds for the benefit of any persons employed by the Company and to subscribe or guarantee money for charitable objects;
- 5.1.21 to make, draw, accept, endorse, issue, discount, and otherwise deal with promissory notes, bills of exchange, cheques, letters of credit, circular notes and other mercantile instruments;

- 5.1.22 to sell, manage, lease, mortgage or dispose of the undertaking or property of the Company or any part thereof for such consideration as the Company may think fit, and to apply the net proceeds of such sale or mortgage for such charitable purposes of the Company as it may think fit and in particular for all or any of the charitable purposes of the Company; to sell, improve, manage, develop, exchange, lease, mortgage, charge, dispose of, turn to account or otherwise deal with all or any of the property and rights of the Company;
- 5.1.23 to acquire and become registered proprietors of copyrights and trade marks and any other form of intellectual property in furtherance of the principal objects;
- 5.1.24 to raise funds and help raise funds for any charitable purpose;
- 5.1.25 to contribute by donation, subscription, loan, guarantee or otherwise to any other charitable object whatsoever;
- 5.1.26 to subscribe to any local or other charities;
- 5.1.27 to construct, maintain, and alter any houses, buildings, or works necessary or convenient for the purposes of the Company;
- 5.1.28 to guarantee, support or secure, whether by personal covenant or by mortgaging or charging all or any part of the undertaking, property and assets (present and future) of the Company, the performance of the obligations of and the repayment or payment of the principle amounts and interest of any person, firm or company or the dividends or interest of any securities, including (without prejudice to the generality of the foregoing) any company which is the Company's holding company or a subsidiary or associated company;
- 5.1.29 to establish or participate in other companies or associations whether as shareholder or member or otherwise;
- 5.1.30 to establish and support, and to aid in the establishment and support of, any other company or association formed for all or any of the principal objects of the Company and to subscribe to any charitable purposes in any way connected with the principal objects of the Company or which may be calculated to further its interests or any of them;
- 5.1.31 to amalgamate with any companies, institutions, societies or associations which are registered charities and which have objects similar to those of the Company;
- 5.1.32 to purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagements of any one or more of the companies, institutions, societies or associations with which the Company is from time to time authorised to amalgamate;
- 5.1.33 to transfer all or any part of the property, assets, liabilities and engagements of the Company to any one or more of the companies, institutions, societies or associations with which the Company is from time to time authorised to amalgamate;

- 5.1.34 to purchase or otherwise acquire and carry on the whole or any part of the business, property, goodwill and assets of any company carrying on or proposing to carry on any business which the Company is authorised to carry on or which can be conveniently carried on in connection with the same, or may seem calculated directly or indirectly to benefit the Company, or possessed of property suitable for the purposes of the Company, and as part of the consideration for any of the acts or things aforesaid or property acquired to undertake all or any of the liabilities of such company or to acquire an interest therein, amalgamate with or enter into any arrangement for sharing profits, or for co-operation, or for mutual assistance with any such company and to give, issue or accept cash or any shares, debentures or other securities that may be agreed upon, and to hold and retain or sell, mortgage and deal with any shares, debentures or securities so received;
- 5.1.35 to promote any company for the purpose of acquiring all or any of the property and/or liabilities of the Company, or if undertaking any business or operations which may appear likely to assist or benefit the Company or to enhance the value of or render more profitable any property, assets or business of the Company, or for any other purpose which may seem directly or indirectly calculated to benefit the Company;
- 5.1.36 to receive and administer and allocate grants and gifts made available to the Company for its principal objects (and whether or not such grants or gifts are made from such public funds or otherwise) under the terms and conditions attached to such grants and gifts;
- 5.1.37 to collect all allocations, fees or other amounts payable for facilities and services provided by the Company;
- 5.1.38 to, create, maintain, invest and deal with any reserve or sinking funds for redemption of obligations of the Company, or for depreciation of works or stock, or any other purpose to advance the principal objects of the Company;
- 5.1.39 to undertake and execute any trusts or any agency business which may seem directly or indirectly conducive to any of the principal objects of the Company;
- 5.1.40 to procure the Company to be registered or recognised in any foreign country, jurisdiction or place;
- 5.1.41 to pay all or any expenses of, incidental to or incurred in connection with the formation and incorporation of the Company and the raising of its loan capital, or to contract with any person or company to pay the same, and to pay commissions to brokers and others for underwriting, placing, selling or guaranteeing the subscription of any debentures or securities of the Company;
- 5.1.42 to promote freedom of contract and to resist, insure against, counteract and discourage interference therewith, to join any lawful federation, union, association or party and to contribute to the funds thereof, or do any other lawful act or thing with a view to preventing or resisting directly or indirectly any interruption of or interference with the Company or any other trade or business or providing or safeguarding against the same, or resisting or opposing any strike, movement or organisation which may be thought

- detrimental to the interest of the Company or its employees and to subscribe to any association or fund for any such purposes;
- 5.1.43 to do all such other lawful things as are incidental or conducive to the preservation of and maintenance of the property of the Company, or the attainment of the principal objects herein before described, provided that in case the Company shall take or hold any property subject to the jurisdiction of the Charities Regulator, the Company shall, if required by the Charities Regulator, vest the same in special trustees thereof and provided that as regards any such property the Company shall not sell, mortgage, charge, lease, dispose of or otherwise deal with the same without such consent as may be required by law;
- 5.1.44 to carry on any business, which may seem to the Company capable of being conveniently carried on in connection with the principal objects or calculated directly or indirectly to enhance the value of or render profitable any of the Company's property, rights or interests; and
- 5.1.45 to do all or any of the above things in any part of the world, and as principals, agents, contractors, trustees or otherwise, and either by or through trustees, agents, sub-contractors or otherwise and either alone in partnership or conjunction with any person, company or association, and to contract for the carrying on of any operation connected with the Company's principal objects by any person, company or association.

### 6 LIMITATION ON OBJECTS AND POWERS

- 6.1 The Company shall not support with its funds or endeavour to impose on or procure to be observed by its Members or others any regulation or restriction which, if an object of the Company, would make it a trade union.
- 6.2 The above objects shall not be construed in any way so as to render any of them otherwise than exclusively charitable.
- 6.3 The objects and powers contained in clauses 4 and 5 are ancillary and subsidiary to the principal objects set out in clause 3.

## 7 LIMITATION OF LIABILITY

7.1 The liability of the Members is limited.

### 8 GUARANTEE OF MEMBERS

- 8.1 Every Member undertakes to contribute to the assets of the Company in the event of the Company being wound up while he is a Member or within one year after he ceases to be a Member, for:-
  - 8.1.1 payment of the debt and liabilities of the Company contracted before he ceases to be a Member, and of the costs, charges and expenses of winding up; and
  - 8.1.2 the adjustment of the rights of the contributories among themselves,

such amount as may be required not exceeding €1.27 (EUR 1.27).

#### 9 WINDING UP

If upon the winding up or dissolution of the Company there remains, after the satisfaction of all its debts and liabilities, any property whatsoever, it shall not be paid to or distributed among the Members. Instead, such property shall be given or transferred to some other company or companies (being a charitable institution or institutions) having principal objects similar to the principal objects of the Company. The company or companies (being a charitable institution or institutions) to which the property is to be given or transferred shall prohibit the distribution of its or their income and property among its or their members to an extent at least as great as is imposed on the Company under or by virtue of clause 10 hereof. Members shall select the company or companies (being a charitable institution or institutions) at or before the time of dissolution.

Final accounts will be prepared and submitted that will include a section that identifies and values any assets transferred along with the details of the recipients and the terms of the transfer.

## 10 PROHIBITION ON PAYMENTS TO MEMBERS

- 10.1 The income and property of the Company shall be applied solely towards the promotion of its principal objects as set forth in this Memorandum. No portion of the Company's income and property shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise howsoever by way of profit, to the Members (unless a Member is itself a charity). No Director shall be appointed to any office of the Company paid by salary or fees, or receive any remuneration or other benefit in money or money's worth from the Company. However, nothing shall prevent any payment in good faith by the Company of:
  - 10.1.1 reasonable and proper remuneration to any Member, officer or servant of the Company (not being a Director) in return for any services rendered to the Company;
  - 10.1.2 interest at a rate not exceeding 1% above the Euro Interbank Offered Rate ("Euribor") per annum on money lent by any Director or any Member to the Company;
  - 10.1.3 reasonable and proper rent for premises demised or let by any Director or any Member to the Company;
  - 10.1.4 reasonable and proper out-of-pocket expenses incurred by any Director in connection with his attendance to any matter affecting the Company;
  - 10.1.5 fees, remuneration or other benefit in money's worth to any company of which a Director may be a member holding not more than one hundredth part of the issued capital of such company; or,
  - 10.1.6 sums to any Director or to any person with whom a Director has a personal connection (within the meaning of Section 2(1) and 2(2) of the Charities Act) in return for services actually rendered to the Company, pursuant to an agreement entered into in compliance with Section 89 of the Charities Act.

## 11 APPROVALS, ALTERATIONS OR AMENDMENTS

- 11.1 The Company must ensure that the Charities Regulator has a copy of its Constitution. If it is proposed to make an amendment to the Constitution and if such amendment requires the prior approval of the Charities Regulator, advance notice in writing of the proposed changes must be given to the Charities Regulator for approval, and the amendment shall not take effect until such approval is received.
- 11.2 No amendments of any kind shall be made to the provisions of clauses 9 and 10 of the Memorandum and no amendments shall be made to the Constitution to such extent that they would alter the effect of clauses 9 and 10 of the Memorandum, such that there would be non-compliance with the requirements of section 1180 of the Act.

## 12 REVENUE COMMISSIONERS ENTITLED TO ACCOUNTS

12.1 For so long as the Company benefits from charitable tax exempt status from the Revenue Commissioners, annual audited accounts shall be kept and made available to the Revenue Commissioners on request.

### ARTICLES OF ASSOCIATION

## 1 PRELIMINARY

#### 1.1 Definitions

In these Articles:

"Act" means the Companies Act 2014 (as may be amended from time to time);

"Articles" means these Articles of Association;

"Board" means the board of Directors for the time being and from time to time of the Company;

"Charities Act" means the Charities Act 2009 (as may be amended from time to time);

"Charities Regulator" means the Charities Regulatory Authority, a body established by Section 13 of the Charities Act to perform the functions conferred on it by the Charities Act:

"Constitution" means the Memorandum and the Articles;

"Corporate Member" has the meaning attributed to that term in Article 2.2.5;

"**Directors**" means the directors for the time being and from time to time of the Company or the directors present at a meeting of the Board and includes any person, from time to time, occupying the position of director by whatever name called;

"Honorary Life Member" has the meaning attributed to that term in Article 2.2.4;

"Mental Health Association" or "MHA" means a mental health company, association, grouping, or body of individuals, which shares some or all of the objectives of the Company;

"MHA Member" has the meaning attributed to that term in Article 2.2.3;

"Mandatory Provision" means a provision of any of Parts 1 to 14 or Part 18 of the Act (together with any statutory modification thereof in force at the date on which these Articles become binding on the Company) that applies to companies limited by guarantee and that is not an Optional Provision;

"Member" means a member of the Company from time to time, and includes each MHA Member, each Ordinary Member, each Corporate Member and each Honorary Life Member:

"Memorandum" means the Memorandum of Association of the Company;

"month" means a calendar month;

"Optional Provision" means a provision of any of Parts 1 to 14 or Part 18 of the Act (together with any statutory modification thereof in force at the date on which these Articles become binding on the Company) that applies to companies limited by guarantee and that:

- (a) contains a statement to the effect, or is governed by a provision elsewhere to the effect, that the provision applies save to the extent that the Constitution provides otherwise or unless the Constitution states otherwise; or
- (b) is otherwise of such import;

"Ordinary Member" has the meaning attributed to that term in Article 2.2.2;

"Secretary" means any person appointed to perform the duties of the secretary of the Company, and shall include any temporary, assistant or acting secretary;

"Seal" means the common seal of the Company;

"State" means the territory of the Republic of Ireland; and

"year" means a calendar year.

## 1.2 Interpretation

- 1.2.1 Words importing the singular number only shall include the plural number and vice versa. Words importing the masculine gender shall include the feminine gender. Words importing persons shall include corporations.
- 1.2.2 Expressions referring to writing shall, unless the contrary intention appears, be construed as including references to printing, lithography, photography and any other modes of representing or reproducing words in a visible form.
- 1.2.3 Unless the contrary intention appears, words or expressions contained in this Constitution shall bear the same meaning as in the Act, or any statutory modification thereof in force at the date at which this Constitution becomes binding on the Company.
- 1.2.4 Headings and footnotes used in this Constitution are for convenience of reference only and shall not be considered to form part of this Constitution.
- 1.2.5 Subject to the requirements of any Mandatory Provision, to the greatest extent possible the provisions of this Constitution shall take precedence over the provisions of the Act.

#### 2 MEMBERS

#### 2.1 Number of Members

The number of Members at the date of adoption of this Constitution is 74 (seventy four) but the Directors may from time to time register an increase or decrease in the number of Members subject to there always being at least three Members for so long as the Company holds a charitable tax exemption from the Revenue Commissioners.

## 2.2 Appointment and Replacement of Members

- 2.2.1 Those persons admitted to membership by the Directors, and who are either (i) Ordinary Members, (ii) MHA Members, (iii) Honorary Life Members or (iv)Corporate Members shall be the Members.
- 2.2.2 An Ordinary Member is an individual who:

either

- (A) is a Director; or
- (B) is a former Director and has applied for annual membership of the Company and has been admitted to the membership by the Board on an annual basis, subject to meeting the criteria defined by the Board from time to time for Ordinary membership and whose annual subscription is up-to-date.
- 2.2.3 An MHA Member shall be an MHA which:
  - (A) Has applied for annual membership of the Company; and
  - (B) has been admitted to the membership by the Board on an annual basis, subject to meeting the criteria defined by the Board from time to time for MHA membership; and
  - (C) whose annual subscription is up-to-date.
- 2.2.4 An Honorary Life Member is an individual who:
  - (A) has been selected by the Board at its sole discretion as an Honorary Life Member; and
  - (B) has been admitted to the membership by the Board, subject to meeting the criteria defined by the Board from time to time for Honorary Life membership.
- 2.2.5 A Corporate Member is an organisation which:
  - (A) has applied for annual membership of the Company; and
  - (B) has been admitted to the membership by the Board on an annual basis, subject to meeting the criteria defined by the Board from time to time for Corporate membership; and

- (C) whose annual subscription is up-to-date.
- 2.2.6 Applications for membership of the Company shall be submitted to the Board in writing, in a form prescribed by the Board who may approve or reject such application, at its discretion. All MHA Members and Corporate Members must apply annually for membership.
- 2.2.7 Each Ordinary Member and each MHA Member shall have one vote each at general meetings of the Company.
- 2.2.8 Honorary Life Members and Corporate Members do not have any voting rights at general meetings of the Company or otherwise.
- 2.2.9 A Member may resign his membership by serving notice to that effect upon the Secretary at the registered office of the Company, such resignation to take effect no earlier than the date of service of the notice of resignation. The Board shall as soon as is convenient direct that the Member's name be removed from the register of members.
- 2.2.10 A Member shall also cease to be a Member on the happening of any of the following events: -
  - (A) on his death;
  - (B) on his becoming bankrupt or insolvent or compounding with his creditors:
  - (C) on his being convicted of an indictable offence other than an offence under the Road Traffic Acts;
  - (D) on his failure to attend three consecutive general meetings of the Company unless excused by the Board from such attendance;
  - (E) on his failure to comply with directions from the Board as may be issued, from time to time;
  - (F) on his expulsion from membership under the provisions of Article 2.2.12:
  - (G) for Ordinary Members who are Directors only, on ceasing to be a Director subject to the proviso that such persons may re-apply for Ordinary membership in their capacity as former Directors following cessation of directorship; and
  - (H) for MHA Members and Corporate Members only, upon the expiration of their annual membership, if such membership is not renewed.
- 2.2.11 For the avoidance of doubt, an Honorary Life Member may cease to be a Member prior to the end of their life on the happening of any of the events listed in Article 2.2.10.
- 2.2.12 If any Member shall wilfully refuse or neglect to comply with any of the provisions of this Constitution or any bye-laws of the Company or if, in the opinion of the Board his conduct renders him unfit to be a Member, he shall

be liable to expulsion by a resolution of the Board, provided that at least one week before the meeting at which such resolution is passed he shall have been given notice thereof, stating the grounds for his expulsion and providing him with a copy of the intended resolution for his expulsion and that he shall at such meeting and before the passing of such resolution have had an appropriate opportunity of giving orally or in writing any explanation or defence he may think fit. This Article shall apply to each of the four categories of Member.

2.2.13 Any Ordinary Member who is expelled from membership in accordance with Article 2.2.12 and who is a Director shall simultaneously cease to be a Director.

## 2.3 Members' Rights and Obligations

- 2.3.1 Each Member shall, on request, be entitled to be provided with a certificate of membership.
- 2.3.2 Each Member shall use his reasonable endeavours to promote the principal objects and the interests of the Company and shall observe all of the Company's regulations affecting him contained in, or effective pursuant to, this Constitution or the Act.
- 2.3.3 The rights of each Member shall be personal to him and shall not be transferable, transmissible or chargeable by his own act, by operation of law or otherwise.
- 2.3.4 A register shall be kept by the Company containing the names and addresses of all the Members, together with such particulars as may be required by the Act.
- 2.3.5 Save as provided by these Articles, each Member shall be entitled to notice of, and to attend and vote at, general meetings of the Company.
- 2.3.6 The annual subscription of a Member shall be set by the Board from time to time and communicated to Members.

### 3 GENERAL MEETINGS

### 3.1 General Meetings

- 3.1.1 An Annual General Meeting shall be held once in every calendar year, at such time (within a period of not more than 15 months after the holding of the last preceding annual general meeting) and place as may be determined by the Board.
- 3.1.2 Subject to the provisions of Section 176 of the Act, general meetings of the Company may be held inside or outside the State.
- 3.1.3 All general meetings other than annual general meetings shall be called Extraordinary General Meetings.

## 3.2 Notice of General Meetings

- 3.2.1 Subject to section 181 of the Act, a meeting of the Company, other than an adjourned meeting, shall be called in the case of an annual general meeting or an extraordinary general meeting for the passing of a special resolution, by not less than 21 days' notice, and in the case of any other extraordinary general meeting, by not less than 7 days' notice.
- 3.2.2 A meeting of the Company shall, notwithstanding that it is called by shorter notice than that specified in Article 3.2.1, be deemed to have been duly called if it is so agreed by all the Members entitled to attend and vote at the meeting and (unless no statutory auditors of the Company stand appointed in consequence of the Company availing itself of the audit exemption under section 360 or 365 of the Act, and, where relevant, section 399 of the Act has been complied with in that regard), the statutory auditors of the Company.
- 3.2.3 The notice of a meeting shall specify the place, the date and the time of the meeting, the general nature of the business to be transacted at the meeting, in the case of a proposed special resolution, the text or substance of that proposed special resolution and with reasonable prominence a statement that a Member entitled to attend and vote is entitled to appoint a proxy, that a proxy need not be a Member, and the time by which the name of the proxy must be received at the registered office of the Company.
- 3.2.4 In determining whether the correct period of notice has been given by a notice of a meeting, neither the day on which the notice is served nor the day of the meeting for which it is given shall be counted.
- 3.2.5 The accidental omission to give notice of a meeting to, or the non-receipt of notice of a meeting by, any person entitled to receive notice shall not invalidate the proceedings at that meeting.
- 3.2.6 The Directors may, whenever they think fit, convene an extraordinary general meeting and extraordinary general meetings shall also be convened on such requisition or in default may be convened by such requisitionists as are provided for in Section 178 of the Act (as modified by Section 1203 of the Act).
- 3.2.7 If at any time there are not sufficient Directors capable of acting to form a quorum, any Director or any Member may convene an extraordinary general meeting in the same manner as nearly as possible as that in which meetings may be convened by the Directors.
- 3.2.8 Notice of every general meeting of the Company shall be given in the manner provided for in these Articles to such persons as are under the Act and these Articles entitled to receive notices from the Company including every Member, every person being a personal representative or the official assignee in bankruptcy of a Member (where the Member but for his death or bankruptcy would be entitled to receive notice of the meeting), and the statutory auditors for the time being of the Company.
- 3.2.9 Notwithstanding any provision of Article 13, where notice of a general meeting is given by posting by ordinary prepaid post to the usual or notified address of a Member, then, for the purposes of an issue as to whether the correct period

of notice for that meeting has been given, the giving of the notice shall be deemed to have been effected on the expiration of 24 hours following posting.

### 4 PROCEEDINGS AT GENERAL MEETINGS

## 4.1 Proceedings at General Meetings

- 4.1.1 The business of the annual general meeting shall include:
  - (A) the consideration of the Company's statutory financial statements and the report of the Directors and, unless the Company is entitled to and has availed itself of the audit exemption under section 360 or section 365 of the Act, the report of the statutory auditors on those statements and that report;
  - (B) the review by the Members of the Company's affairs;
  - (C) the election and re-election of Directors;
  - (D) the appointment or re-appointment of the statutory auditors; and
  - (E) the fixing of the remuneration of the statutory auditors.

## 4.2 Quorum for General Meetings

- 4.2.1 Save as herein otherwise provided, five Members present in person or by proxy shall be a quorum.
- 4.2.2 No business shall be transacted at any general meeting unless a quorum of Members is present both at the time when the meeting proceeds to business and during the currency of the meeting.
- 4.2.3 If within half an hour after the time appointed for a general meeting a quorum is not present, then the meeting, if convened upon the requisition of Members shall be dissolved; in any other case it shall stand adjourned to the same day in the next week at the same time and place, or to such other day and at such other time and place as the Directors may determine, and if at the adjourned meeting a quorum is not present within half an hour from the time appointed for the meeting, the Members present shall be a quorum.

### 4.3 Chairperson of General Meetings

- 4.3.1 The chairperson, if any, of the Board, or in his absence the vice-chairperson, shall preside as chairperson at every general meeting of the Company, or if there is no such chairperson or vice-chairperson, or if he is not present within 15 minutes after the time appointed for the holding of the meeting or is unwilling to act, the Directors present shall elect one of the other officers, or failing that, one of their number, to be chairperson of the meeting.
- 4.3.2 If at any meeting no Director is willing to act as chairperson or if no Director is present within 15 minutes after the time appointed for holding the meeting, the Members present shall choose one of their number to chair the meeting.

## 4.4 Adjournment of General Meetings

- 4.4.1 The chairperson may, with the consent of any meeting at which a quorum is present, (and shall, if so directed by the meeting) adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.
- 4.4.2 When a meeting is adjourned for 30 days or more, notice of the adjourned meeting shall be given as in the case of an original meeting.
- 4.4.3 When a meeting is adjourned for 29 days or less, it shall not be necessary to give any notice of an adjourned meeting or of the business to be transacted at an adjourned meeting.

## 4.5 Voting at General Meetings

- 4.5.1 At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands) demanded:
  - (A) by the chairperson,
  - (B) by at least three Members present in person or by proxy, or
  - (C) by any Member or Members present in person or by proxy and representing not less than 10 per cent of the total voting rights of all the Members concerned having the right to vote at the meeting.
- 4.5.2 At a meeting, a poll may be demanded in relation to a matter (whether before or on the declaration of the result of the show of hands in relation to it). A demand for a poll may be withdrawn by the person or persons who have made the demand.
- 4.5.3 Subject to the requirements of Article 4.5.4. every Ordinary Member and every MHA Member present in person or by proxy at a general meeting shall have one vote.
- 4.5.4 Members with voting rights may only exercise the right to vote if their names appear on the Company's register of members 21 days prior to the date of the general meeting.
- 4.5.5 No Member shall be entitled to vote at any general meeting unless all monies immediately payable by the Member to the Company have been paid.
- 4.5.6 No objection shall be raised as to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is given or tendered, and every vote not disallowed at such meeting shall be valid for all purposes. Any such objection made in due time shall be referred to the chairperson of the meeting whose decision shall be final and conclusive.
- 4.5.7 Unless a poll is so demanded (and the demand not be withdrawn), a declaration by the chairperson that a resolution has, on a show of hands, been carried or carried unanimously or by a particular majority or lost, and an

- entry to that effect in the minutes of the proceedings, shall be conclusive evidence of the fact without proof of the number or proportion of the votes recorded in favour of or against such resolution.
- 4.5.8 Except as provided in Article 4.5.10, if a poll is duly demanded (and the demand is not withdrawn) it shall be taken in such manner as the chairperson directs and the result of the poll shall be deemed to be the resolution, in relation to the matter concerned, of the meeting at which the poll was demanded.
- 4.5.9 Where there is an equality of votes, whether on a show of hands or on a poll, the chairperson of the meeting at which the show of hands takes place or at which the poll is demanded, shall be entitled to a second or casting vote.
- 4.5.10 A poll demanded on the election of the position of chairperson of the meeting or on a question of adjournment shall be taken forthwith. A poll demanded on any other question shall be taken at such time as the chairperson of the meeting directs, and any business other than that upon which a poll has been demanded may be proceeded with pending the taking of the poll.
- 4.5.11 Subject to Sections 191 to 198 of the Act, a resolution in writing signed by all the Members for the time being entitled to attend and vote on such resolution at a general meeting (or being bodies corporate by their duly authorised representatives) shall be as valid and effective for all purposes as if the resolution had been passed at a general meeting of the Company duly convened and held, and if described as a special resolution, shall be deemed to be a special resolution within the meaning of the Act. A resolution in writing made pursuant to this Article 4.5.11 may consist of one document or two or more documents in like form each signed by one or more Members.

## 4.6 Voting by Proxy

- 4.6.1 Votes may be given either personally, or by proxy. A proxy shall have the same right as the Member appointing him to speak at the meeting and to vote on a show of hands and on a poll.
- 4.6.2 A Member shall not be entitled to appoint more than one proxy to attend on the same occasion. A proxy need not be a Member.
- 4.6.3 The instrument appointing a proxy (the "instrument of proxy") shall be in writing under the hand of the appointer or of his attorney duly authorised in writing, or, if the appointer is a body corporate, either under seal of the body corporate or under the hand of an officer or attorney of it duly authorised in writing.
- 4.6.4 The instrument of proxy and the power of attorney or other authority, if any, under which it is signed, or a notarially certified copy of that power or authority shall be deposited at the registered office of the Company (or at such other place within the State as is specified for that purpose in the notice convening the meeting), and shall be so deposited not later than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposed to vote, or, in the case of a poll, 48 hours before the time appointed for the taking of the poll.

- 4.6.5 The depositing of the instrument of proxy (or other document) referred to in Article 4.6.4 may, rather than posting or delivering it, be effected by communicating the instrument to the Company by electronic means.
- 4.6.6 An instrument of proxy shall be in the following form or a form as near thereto as circumstances permit:

- 4.6.7 The instrument of proxy shall be deemed to confer authority to demand or join in demanding a poll.
- 4.6.8 A vote in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or insanity of the appointer or revocation of the proxy or of the authority under which the proxy was executed, if no notice in writing of such death, insanity or revocation as aforesaid is received by the Company at the registered office of the Company before the commencement of the meeting or adjourned meeting at which the proxy is used.
- 4.6.9 Any body corporate which is a Member may by resolution of its directors or other governing body authorise such persons as it thinks fit to act as its representative at any meeting of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the body corporate which he represents as that body corporate could exercise if it were an individual Member.

## 5 BOARD OF DIRECTORS

## 5.1 Directors' Powers of Management

- 5.1.1 The business of the Company shall be managed by the Directors, who may exercise all such powers of the Company as are not, by the Act or by this Constitution, required to be exercised by the Company in general meeting, but subject to:
  - (A) the provisions of this Constitution;
  - (B) the provisions of the Act; and
  - (C) such directions, not being inconsistent with the foregoing provisions, as the Company in general meeting may (by special resolution) give, provided that no direction given by the Company in general meeting shall invalidate any prior act of the Directors which would have been valid if that direction had not been given.

## 5.2 Appointment of Directors

- 5.2.1 Any purported appointment of a Director without that Director's consent shall be void.
- 5.2.2 Subject to the provisions of Article 5.2.1, the first Directors shall be those persons determined in writing by the subscribers of this Constitution or a majority of them. Thereafter, the Directors shall be elected by the Company in general meeting or otherwise appointed in accordance with this Constitution.
- 5.2.3 The Directors shall be appointed with a view to ensuring a broad range of skills and talents on the Board and to allow appropriate input from those with requisite knowledge of the MHAs.
- 5.2.4 The Board has prescribed four geographical areas in the State as regions of the Company ("Regions"). Each such Region shall have a Regional Committee, with a structure and composition approved by the Board. Each Region shall have the right to nominate one individual from its Region, who has requisite knowledge of the MHAs and who is eligible for both membership and directorship, to be a Director. This nomination right shall mean that the individual in question may be put forward to a general meeting of the Company for election as a Director in accordance with the provisions of these Articles. All Members with voting rights are eligible to vote in such election.
- 5.2.5 In its election of new Directors at general meeting the Company shall use reasonable endeavours to ensure that, at any given point in time, four Directors are individuals referred to at Article 5.2.4 above, one emanating from each of the four Regions.
- 5.2.6 Where, at any given point in time, four Directors are not individuals referred to at Article 5.2.4 above, (one emanating from each of the four Regions), the relevant Regional Committee shall convene to nominate an individual for appointment as a Director at the next following general meeting of the Company.

- 5.2.7 The Board shall be comprised of no less than five and no more than thirteen Directors.
- 5.2.8 The Company may from time to time, by ordinary resolution, increase or reduce the number of Directors, and may also determine in what rotation the increased or reduced number is to go out of office.
- 5.2.9 The Board shall have power at any time, and from time to time, to appoint any person to be a Director, either to fill a casual vacancy or as an addition to the existing Directors, but so that the total number of Directors shall not at any time exceed the number fixed in accordance with these Articles.
- 5.2.10 Without prejudice to the powers of the Directors under Article 5.2.9, the Company in general meeting may by ordinary resolution appoint any person to be a Director, either to fill a casual vacancy or as an addition to the existing Directors, but so that the total number of Directors shall not at any time exceed the number fixed in accordance with these Articles.
- 5.2.11 The Company may by ordinary resolution appoint another person in place of a Director removed from office under Article 5.4.1.
- 5.2.12 The Board shall elect from among the Directors, the following officers of the Company namely: chairperson and vice-chairperson. The elected chairperson and vice-chairperson may each hold office for a two year term, renewable once.

## 5.3 Rotation of Directors

- 5.3.1 The term of office of each Director shall be three years, commencing on the date upon which he is elected to the Board by the Company in general meeting. Any period of time served on the Board prior to the appointment by the Members in general meeting shall not be counted in calculating the three year term of office of a Director. The term of office of a Director may be extended for one further three year term following the expiry of the first three year term. Following any such extension the Director shall stand down and shall be ineligible for reappointment to the Board for a further three year period.
- 5.3.2 At every annual general meeting of the Company, those Directors for the time being whose term of office (as determined in accordance with these Articles and in particular Articles 5.2 and 5.3) has expired, shall retire from office.
- 5.3.3 The Company, at the meeting at which a Director retires in manner aforesaid, may fill the vacated office by electing a person thereto, and in default the retiring Director shall, if offering himself for re-election, be deemed to have been re-elected, unless at such meeting it is expressly resolved not to fill such vacated office or unless a resolution for the re-election of such Director has been put to the meeting and lost.
- 5.3.4 No person other than a Director retiring at the annual general meeting shall, unless recommended by the Directors or unless he is a nominee from a Region, be eligible for election to the office of Director at any general meeting unless, not less than 3 nor more than 21 days before the date appointed for the meeting, there has been left at the office notice in writing, signed by a

- Member duly qualified to attend and vote at the meeting for which such notice is given, of his intention to propose such a person for election, and also notice in writing signed by that person of his willingness to be elected.
- 5.3.5 Any Director appointed in accordance with Article 5.2.9 shall hold office only until the next annual general meeting, and shall then be eligible for election by the Company in general meeting, but shall not be taken into account in determining the Directors who are to retire by rotation at such meeting.
- 5.3.6 A person appointed as a Director in accordance with Article 5.2.11 shall be subject to retirement at the same time as if they had become a Director on the day on which the Director in whose place they are appointed was last elected a Director.

#### 5.4 Removal of Directors and Vacation of Office

- 5.4.1 The Company may by ordinary resolution remove any Director before the expiration of his period of office, notwithstanding anything in these Articles or in any agreement between the Company and such Director. Such removal shall be without prejudice to any claim such Director may have for damages for breach of any contract of service between him and the Company.
- 5.4.2 The office of Director shall be vacated if:
  - (A) the Director ceases to be a Member for any reason;
  - (B) the Director is adjudged bankrupt, or being a bankrupt, has not obtained a certificate of discharge in the relevant jurisdiction, or makes any arrangement or composition with his creditors generally;
  - (C) the Director becomes or is deemed to be subject to a disqualification order within the meaning of Chapter 4 of Part 14 of the Act;
  - (D) the health of the Director is such that he can no longer be reasonably regarded as possessing an adequate decision making capacity or is rendered incapable of managing and administering his property and affairs;
  - (E) the Director resigns his office by notice in writing to the Company;
  - (F) the Director is directly or indirectly interested in a contract with the Company and fails to declare the nature of his interest in the manner required by section 231 of the Act;
  - (G) the Director is absent for three or more consecutive meetings of the Board unless the Board otherwise determines:
  - (H) the Director holds any office or place of profit in the Company save as permitted by Section 89 of the Charities Act (once commenced);
  - (I) the Director is disqualified from being a charity trustee of any charitable organisation pursuant to Section 55 of the Charities Act;

- (J) the Director becomes a restricted person within the meaning of Chapter 3 of Part 14 of the Act and the Directors resolve that his office be vacated:
- (K) the Director is convicted of an indictable offence unless the Board otherwise determines;
- (L) the Director is requested in writing by at least 75% of his co-Directors to resign; or
- (M) the Director no longer holds the position which entitles him to be a Director.
- 5.4.3 The death of a Director shall also terminate his directorship with immediate effect.

## 5.5 Chairperson of the Board

5.5.1 The chairperson, or, in his absence, the vice-chairperson, shall preside at all meetings of the Board, but if at any meeting neither the chairperson nor vice-chairperson is present within 15 minutes after the time appointed for holding the same, the Directors present may choose one of their number to be chairperson of the meeting.

### 6 POWERS AND DUTIES OF THE BOARD OF DIRECTORS

## 6.1 Borrowing Powers

6.1.1 The Board may exercise all the powers of the Company to borrow money and to mortgage or charge its undertaking and property or any part thereof and to issue debentures, debenture stock and other securities, whether outright or as security for any debt, liability or obligations of the Company.

## 6.2 Specific Duties of the Board

- 6.2.1 All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments, and all receipts for moneys paid to the Company, shall be signed, drawn, accepted, endorsed or otherwise executed, as the case may be, by such person or persons and in such manner as the Directors shall from time to time by resolution determine.
- 6.2.2 The Directors shall cause minutes to be made in books provided for the purpose:
  - (A) of all appointments of officers made by the Directors;
  - (B) of the names of the Directors present at each meeting of the Directors and of any committee of the Directors;
  - (C) of all resolutions and proceedings at all meetings of the Company and of the Directors and of committees of Directors.

6.2.3 Any such minute, if purporting to be signed by the chairperson of the meeting at which the proceedings were held, or by the chairperson of the next succeeding meeting, shall be evidence of the proceedings.

### 7 PROCEEDINGS OF THE BOARD OF DIRECTORS

## 7.1 Regulation of Meetings of the Board of Directors

- 7.1.1 The Directors may meet together for the dispatch of business, adjourn and otherwise regulate their meetings as they think fit.
- 7.1.2 The Board shall hold a minimum of five meetings every year.
- 7.1.3 A Director may, and the Secretary on the requisition of a Director shall, at any time summon a meeting of the Directors.
- 7.1.4 All Directors shall be entitled to reasonable notice of any meeting of the Directors but, if the Directors so resolve, it shall not be necessary to give notice of a meeting of the Directors to any Director who, being resident in the State, is for the time being absent from the State.
- 7.1.5 A resolution in writing signed by all the Directors for the time being entitled to receive notice of a meeting of the Directors shall be as valid as if it had been passed at a meeting of the Directors duly convened and held and may consist of several documents in the like form each signed by one or more of the Directors. Any such resolution in writing may consist of several documents in like form, each signed by one or more of the Directors and for all purposes shall take effect upon receipt at the registered office of the Company of all such several documents, by facsimile transmission or otherwise.
- 7.1.6 Any Director or member of a committee of the Board may participate in a meeting of the Directors or such committee by means of a conference or other telecommunication facility between some or all of the Directors, or as the case may be, members of the committee who are not all in one place, but each of whom is able, (directly or by means of telephonic, video or other electronic communication) to speak to each of the others and to be heard by each of the others. Any Director or member of a committee participating at such a meeting will be deemed to be present in person at such meeting and shall be entitled to vote and be counted in a quorum accordingly.
- 7.1.7 All acts done by any meeting of the Directors or of a committee of Directors or by any person acting as a Director shall, notwithstanding that it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Director.
- 7.1.8 A Director may waive notice of any meeting, and such waiver may be retrospective.

### 7.2 Voting at Meetings of the Board

7.2.1 Questions arising at any meeting shall be decided by a majority of votes.

- 7.2.2 Where there is an equality of votes, the chairperson shall have a second or casting vote.
- 7.2.3 A Director shall not vote in respect of any contract in which he is interested or any matter arising therefrom, and shall be obliged to declare the nature of his interest.

## 7.3 Quorum for Meetings of the Board

- 7.3.1 The quorum necessary for the transaction of the business of the Directors may be fixed by the Directors, and unless so fixed shall be five.
- 7.3.2 The continuing Directors or a sole Director may act notwithstanding any vacancies in their number, but, if the number of Directors is less than the number fixed for the quorum, they may act only for the purposes of filling vacancies or calling a general meeting.

## 8 COMMITTEES

## 8.1 Establishment and Regulation of Committees

- 8.1.1 The Directors may establish one or more committees, consisting in whole or part of Directors, as they think fit for such purposes, and with such functions as the Directors shall determine and, without prejudice to section 40 of the Act, the Directors may delegate any of their powers to such person or persons as they think fit, including committees.
- 8.1.2 Any committee formed by the Directors shall, in the exercise of the powers delegated to it, conform to any regulations that may be imposed on it by the Directors.
- 8.1.3 All committees established by the Directors shall be responsible to and report to the Directors.

## 8.2 Proceedings of Committees

- 8.2.1 The Board may, if it sees fit, appoint a chairperson to a committee or in the absence of such an appointment a committee may elect a chairperson of its meetings. If no such chairperson is elected, or if at any meeting the chairperson is not present within 15 minutes after the time appointed for holding the same, the members present may choose one of their number to be chairperson of the meeting.
- 8.2.2 A committee may meet and adjourn as it thinks proper.
- 8.2.3 Questions arising at any meeting of a committee shall be determined by a majority of votes of the members present, and where there is an equality of votes, the chairperson shall have a second or casting vote.

### 9 SECRETARY

## 9.1 Company Secretary

- 9.1.1 The Secretary shall be appointed by the Directors for such term and upon such conditions as they may think fit and any Secretary so appointed may be removed by them.
- 9.1.2 The Directors may appoint an assistant or deputy secretary and any provision in these Articles requiring or authorising a thing to be done by or to the Secretary shall be satisfied by it being done by or to the assistant or deputy secretary.
- 9.1.3 A provision of the Act or these Articles requiring or authorising a thing to be done by or to a Director and the Secretary shall not be satisfied by its being done by or to the same person acting both as Director and as, or in place of, the Secretary.
- 9.1.4 The Directors have a duty to ensure that the person appointed as Secretary has the skills or resources necessary to discharge his statutory and other duties.

#### 10 THE SEAL

### 10.1 Use of the Seal

- 10.1.1 The Seal shall be used only by the authority of the Board or of a committee of the Board authorised by the Board in that behalf.
- 10.1.2 Any instrument to which the Seal shall be affixed shall be signed by a Director or by some other person appointed for the purpose by the Directors or by a foregoing committee of them, and shall be countersigned by the Secretary or by a second Director or by some other person appointed by the Directors or by a forgoing committee of them for that purpose.
- 10.1.3 If a registered person has been authorised by the Company under Section 39(1) of the Act, the Seal may be used by such person and any instrument to which the Seal shall be affixed when it is used by the registered person shall be signed by that person and countersigned:
  - (A) by the Secretary or a Director; or
  - (B) by some other person appointed for the purpose by the Directors or a committee of the Directors authorised by the Directors in that behalf.

### 11 ACCOUNTS

## 11.1 Preparation and Keeping of Accounts

- 11.1.1 The Board shall cause adequate accounting records to be kept relating to:
  - (A) all sums of money received and expended by the Company and the matters in respect of which the receipt and expenditure takes place;

- (B) the assets and liabilities of the Company; and
- (C) all sales and purchases of goods by the Company.
- 11.1.2 Adequate accounting records shall be deemed to have been maintained if they explain the Company's transactions and facilitate the preparation of financial statements that give a true and fair view of the assets, liabilities, financial position and profit or loss of the Company.
- 11.1.3 The accounting records shall be kept at the registered office of the Company or, subject to Section 283 of the Act, at such other place as the Board thinks fit, and shall at all reasonable times be open to the inspection of the Directors.
- 11.1.4 The Directors shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations the accounting records of the Company shall be open to the inspection of Members who are not Directors, and no Member (not being a Director) shall have any right of inspection of any accounting records or document of the Company except as conferred by statute or authorised by the Directors or by the Company in general meeting.

## 11.2 Laying of Accounts Before Annual General Meeting

- 11.2.1 The Directors shall from time to time in accordance with Chapter 4 of Part 6 of the Act cause to be prepared and to be laid before the annual general meeting of the Company such profit and loss account, balance sheet, and reports as are required by that Chapter to be prepared and laid before the annual general meeting of the Company.
- 11.2.2 A copy of the balance sheet (including every document required by law to be annexed thereto) which is to be laid before the annual general meeting of the Company together with a copy of the Directors' report and statutory auditors' report shall, not less than 21 days before the date of the annual general meeting, be sent to every person entitled under the provisions of the Act to receive them.

### 12 AUDIT

### 12.1 Audit

12.1.1 Auditors shall be appointed and their duties regulated in accordance with the provisions of the Act dealing with such matters.

### 13 NOTICES

### 13.1 Notices

- 13.1.1 A notice may be given by the Company to any Member either in writing or by electronic means subject to the provisions of this Article 13.
- 13.1.2 A notice in writing may be served on or given to the Member in one of the following ways:
  - (A) by delivering it by hand to the Member;

- (B) by leaving it at the usual or notified address of the Member;
- (C) by sending it by post in a prepaid letter or by courier to the usual or notified address of the Member; or
- (D) by electronic means.
- 13.1.3 Any notice served or given in accordance with the provisions of Article 13.1.2 shall be deemed, in the absence of any agreement to the contrary between the Company and the Member, to have been served or given:
  - in the case of its being delivered, at the time of delivery (or, if delivery is refused, when tendered);
  - (B) in the case of it being left, at the time that it is left;
  - (C) in the case of it being posted (to an address in the State) on any day other than a Friday, Saturday or Sunday, 24 hours after dispatch and in the case of its being posted (to such an address):
    - (1) on a Friday 72 hours after dispatch; or
    - (2) on a Saturday or Sunday 48 hours after dispatch;
  - (D) in the case of it being posted (to an address outside the State) on any day other than a Friday, Saturday or Sunday, 24 hours after dispatch and in the case of its being posted (to such an address):
    - (1) on a Friday 168 hours after dispatch; or
    - (2) on a Saturday or Sunday 120 hours after dispatch; or,
  - (E) in the case of electronic mail, at the time it was sent,

but subject to Section 181(3) of the Act (as reproduced at Article 3.2.9 of these Articles) regarding notice of general meetings.

### 14 WINDING-UP

### 14.1 Winding Up

14.1.1 If the Company shall be wound up, the provisions contained in clause 9 of the Memorandum shall be performed and have effect in all respects as if the same were repeated in these Articles.

### 15 INDEMNITY

## 15.1 Indemnity

15.1.1 Subject to the provisions of the Act every Director or member of a committee appointed by the Board or any agent of the Board or such a committee, auditors, Secretary and every other officer for the time being of the Company shall be indemnified out of the assets of the Company against any liability

incurred by any of them in defending any proceedings, whether civil or criminal, in relation to their acts while acting in such capacity where judgment is given in their favour or in which they are acquitted, or in connection with any application under Section 233 of the Act in which relief is granted to them by the Court.

## 16 OPTIONAL PROVISIONS

## 16.1 Optional Provisions

16.1.1 The Optional Provisions of the Act listed in column 1 below shall not apply to the Company. To the extent that a given Optional Provision has been replaced by or restated in or dis-applied by these Articles or by the Memorandum, this is identified in column 2 below.
